# <u>Subject: Consultancy and support to Department of Wildlife Protection, Jambu Zoo for Nature Interpretation Centre.</u>

The Department of Wildlife Protection, Jammu and Kashmir, establishing a Zoo in Jammu. The total area of Jambu Zoo is 229.5 hectare at Co. 4/R Khanpur Nagrota Jammu. The visitors can be an important target group for achieving the objectives of spreading awareness and education on environment and wildlife conservation and sensitizing the public towards protecting and conserving the wildlife. The Zoo would serve as added tourist attraction as many recreation amities have been proposed in the project. This will give boost to overall tourism activities in the state.

There is space allocated for Nature Interpretation Centre at the Jambu Zoo.

The <u>"Expression of Interest"</u> is thus invited from reputed National and International Level expert agency/institutions/consultants, having experience of similar nature of works, for conceptualizing and developing the Nature Interpretation Centre.

The ideas on material and techniques of displays/ interpretation items related to the flora and fauna as proposed by the tenderer, following topics/ vital components, must be incorporated in the concept proposal for the new Nature Interpretation centre:

### Scope of work

- 1. Architectural design, Front elevation of Nature Interpretation centre.
- 2. A hall with sitting capacity of 150 persons.
- 3. Latest technology / user friendly audio visual modeling (3D) for the exhibits i.e flora & fauna.
- 4. Interactive models/games/puzzles.
- 5. To depict key features of J&K and information on rich biodiversity of flora & fauna.
- 6. Endangered Species related information.
- 7. Threats and Conservation efforts being taken up in the State.

8. Preparation of DPR, inviting Tenders, examination of Bids offered recommendation of successful bidder and monitoring of execution & post commission performance.

#### Methodology & time schedule:

#### Phase -1 Data collection and Design

- Visit the site
- Collection and collation of various data & information as provided by the Department of Wildlife Protection, J&K
- Suggestion suitable intervention based on inferences drawn.

The duration of this phase will be approximately 7 days.

### Phase -2 Data collection and Design Concept

- Based on the inferences drawn and intervention suggested from phase -1, concept design to be prepared for the items mentioned in the objective in the form of visual representations (PPT).
- Submission of Architectural design and structural drawing to the Department of Wildlife Protection, J&K
- Further detailing of approval Design / Drawing.

The duration of this phase will be approximately 15 days.

#### Phase -3 Submission of Final DPR of identified intervention

• DPR of identified activities be prepared along with tender documents.

The duration of this phase will be approximately **15 days.** This phase will commence only after the formal approval of Phase -2.
