Subject: Compassionate appointment of Shri Jeevanjott Singh S/o Late Sh. Kalyan Singh (Deceased Helper) R/o Dara Dullian Tehsil Haveli District Poonch under the provisions of SRO-43 of 1994.

ORDER: 332 of 2023 Date d: 35 - 11 - 2023

Sanction is hereby accorded to the temporary appointment of Shri Jeevanjott Singh S/o Late Sh. Kalyan Singh (Deceased Helper) R/o Dara Dullian Tehsil Haveli District Poonch, as MTS (Watcher), in the Pay level SL-1 (14800-47100), under the provisions of SRO-43 of 1994.

The appointee shall report to the Regional Wildlife Warden, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following document certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

(a) That if the appointee has taken loan for self-employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of the unit/ enterprise and also stakes, if any, in such self-employment unit/ enterprise before joining the Government Service. He shall be

required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, such as self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.

- (b) That the salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of qualification/ Date of Birth/ Relevant Category Certificate is received from the authorities/agency.
- (c) That the appointee shall be on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the 'New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) That inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- (f) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
