Whereas, the Govt. of Jammu & Kashmir has vide its notification SRO 138 of 10th April-1999 Issued under endorsement NO:-FST/G/WL/SE dated:-10-4-1999, in exercise of the powers conferred vide Section 17 of J&K Wild Life Protection Act-1978 declared the areas of Surainsar-Mansar Tehsil Ramnagar specified in Annexure 'A' of the above notification as a sanctuary.

Now, therefore, I, Mohammad Sayeed Khan, Distt. Collector(Deputy Commissioner) Udhampur in exercise of the powers vested in me under Section 18 & 20 of the above Act, do call upon any person or persons, claiming any right mentioned in section 18 to present before the undersigned within two months from the date of this proclamation in the Govt. Gazette, a written claim in the prescribed form specifying the nature and extent of such right with necessary detail and copies of substantiating documents and particulars of compensation if any, claimed in respect thereof. No objection whatsoever shall be entertained after the expiry of the above mentioned period.
