- 01.** The Bids shall be deposited in electronic format on the Departmental Website:- <https://jktenders.gov.in>.
- 02.** The price bids uploaded on the website in time will be opened after the evaluation of the Technical Bids by the Engineering Wing of the Department. The dates of opening price bids as per NIT. The price bids will also be opened in the office of Conservator Of Forest/Wildlife, Manda Hills, Jammu.
- 03.** Bids must accompany cost of tender document as shown against each work in the shape of demand draft in favour of **Wildlife Warden, Jambuu Zoo, Manda hills Jammu Near Hotel Ashok Jammu** and earnest money in shape of **CDR/FDR pledge to Wildlife Warden Jambu Zoo, Jammu**. The bids for the work shall remain valid for a period of 90 days from the date of opening of bids.
- 04.** In case the cost of lowest bidder is found below the advertised amount, the bidder has to deposit an additional security performance in the shape of CDR/FDR before issuance of award of contract to the tune as per below details:-
 1. Upto 10% below rate over advertised cost Nil
 2. 10% to 20% below rate over advertised cost 3% of advertised cost in shape of CDR/FDR.
 3. 20% to 30% below rate over advertised cost 5% of advertised cost in shape of CDR/FDR.
 4. 30% below rate over advertised cost 5% in shape of CDR/FDR of advertised cost & 5% in shape of bank guarantee of advertised cost.
- 05.** Bidders are advised to download bid submission manual from the “Downloads” options as well as from “ Bidders Manual Kit” on website www.jktenders.gov.in
- 06.** To participate in bidding process , bidders have to get Digital Signature Certificate(DSC) as per IT Act, bidders can get Digital Signature Certificate from approved vendor.
- 07.** The Bidders have to submit their financial bids online in electronic format with digital signature . **No financial bid will be accepted in physical /hard form.**
- 08.** Bids will be opened only after accord of Technical sanction and administrative approval.
- 09.** Bidders must ensure to upload scanned copies of all necessary documents i.e **CDR,PAN,TIN, Demand Draft, Registration Card, and turnover certificate, certificate of work completion from principal employee.** Hard copies of all these documents should also reach to the office of (In the Office of Wildlife Warden Jambu Zoo, Manda Hills, Jammu) on **06-06-2017 up to 2:00 PM. No registered post/courier will be accepted.**
- 10.** The Department will not be responsible for any delay in online submission of the bid due to any reason(Technical or otherwise).
- 11.** The Department shall not be held responsible for selection criteria/policy matter being adopted by the Directorate of Information regarding publishing the e-NIT, in any of the newspaper under circulation.
- 12.** The accepting department however reserves the right to reject any or all the tenders without assigning any reasons thereof.

- 13.** The contractor shall arrange the key materials like Cement, Steel on his own from authorized dealers for the above said work and quality of material shall be ISI marked and have to be verified/passed by the concerned Engineering wing and Officers of the department before the start of work.
- Cement: As per ISI mark
 - Steel/Mesh: As per ISI mark/Hard dip
- 14.** The Department reserves the right to cancel (withdraw) the tender without assigning any reasons thereof.
- 15.** The design of main entry gate should be vetted & approved by the Chief Engineer Design Inspection Quality Control Department by contractor whose bid is finalized.
- 16.** All other terms and conditions shall remain same as per PWD Form 25(double leaf) and as per the detailed document.
