- d) In relation to measures to be taken for harmonising needs of the tribals and other dwellers of the forest with the protection and conservation of wildlife; and
- e) In any other matter(s) connected with the protection of wildlife which may be referred to it by the Government of the Union territory of Jammu and Kashmir.


