The E.M.D of the successful tenders shall be accounted for towards part of the contract. Any tender received without earnest money deposit in the shape of C.D.R/FDR will be rejected.

- The earnest money deposit of Second lowest tenderer will be retained till the sanction is issued in favour of the successful tenderer. The C.D.R for the other unsuccessful tenderers will be released immediately after opening of the tenders.

No telegraphic tender after the tenders are opened shall be considered.
- The tenders should be clearly written in ink legibly. The cutting, errors and interpolations if any without the signature of the tenderers shall make the tender invalid.

General Terms & Conditions:

- 1. The rates for the supply of item as shown in the schedule Annexure "A" be quoted per kg FOR Manda Jammu and FOR Tanday Udhampur and FOR Mantalai Sudhmahdev.
- 2. The rates quoted should be inclusive of all the taxes, excise duty or any other levy etc.
- 3. Mutton supplied be clean, fresh, boney and free from excessive fat.
- 4. The cattle feed be of approved brand, odourless, high nutritious value & the tenderer should handover the sample duly sealed & specify the brand at the time of tendering.
- 5. The approximate supply for Green Fodder, Cattle Feed, Mixed Feed, Emu Feed, Fresh Mixed Fruit, Fresh Mix Vegetable, Mutton & Chicken Meat dressed per day is shown in the schedule Annexure-A enclosed hereto which may change depending on the increase/ decrease in number of animals kept at the concerned Deer Park without prior notice to the contractor.
- 6. No conditional tender will be entertained.
- 7. The rates offered by the successful tenderer/ lowest bidder shall be submitted to the competent authority for approval will have to execute an agreement with the Department/ office within a period of seven days from the date of issue of approval in his favour. In case of his failure, the sanction issued will be cancelled and earnest money deposit will be forfeited.
- 8. The Feed and Fodder should be fresh and of standard quality.
- 9. The undersigned reserve the right to accept or reject any tender in whole or part without assigning any reason thereof.
- 10. In case of any dispute arising between the parties concerned the matter will be referred to the Chief Conservator of Forest (Wildlife) Jammu for arbitration and his decision will be final and binding on both the parties.
- 11. After receipt of bill in duplicate for the month of supply duly authenticated by the Range Officer concerned, the due payment will be released in favour of the approved contractor subject to the availability of funds. The income tax if payable under rules will be deducted at source as per the guidelines issued by the Income Tax Department from time to time.
- 12. In case of default in making daily supply of Green Fodder, Cattle Feed, Mixed Feed, Emu Feed, Fresh Mixed Fruit, Fresh Mix Vegetable, Mutton & Chicken Meat dressed by the approved contractor, the concerned required material will be purchased from the open market at the cost, risk and responsibility of the concerned contractor. The difference if any in rates approved and rates charged for arranging the supply from open market shall be debited to the pending payments/ security deposit to the contractor.
- 13. The E.M.D of the successful tender will remain as security deposit with the office.
- 14. Any other condition will be communicated at the opening of the tenders.
