Subject: Final Seniority List of Wildlife Guards of Kashmir Region ending June, 2014.

C I R C U L A R

Whereas, a tentative seniority list of Guards was notified vide No.CF(WL)/K/Estt/2014/67-75, Dated:- 05-05-2014 for information of all concerned and for inviting objections thereof within a period of (21) days from the date of first publication in local daily.

Whereas, for wide publicity, the said tentative seniority list was circulated through respective Divisional offices, besides a Notification was also published in the daily "Greater Kashmir" on 09-05-2014.

Whereas, objections were received directly and through concerned Wildlife Wardens for consideration.

Whereas, the objections received were examined and scrutinized.

Whereas, necessary corrections wherever required, were made after considering all genuine objections so received.

Whereas, the representation from one Shri Bashir Ahmad Ganai (Guard) – II was received through Wildlife Warden Shopian stated that his name does not figure in the tentative seniority list of Guards.

Whereas, the matter was scrutinized and it was found that due to the transfer of Shri Bashir Ahmad Ganai (Guard) – II from one Division to another and non-submission of his service particulars, the name of the official could not figure in the tentative seniority list of Guards.

Whereas, his name has been now incorporated in the seniority list at an appropriate place.

Whereas, some Wildlife Guards while challenging the tentative seniority list of Guards approached the Hon'ble High Court and filed a Writ Petition under SWP No. 1200/2014, CMP No. 1934/2014 titled "**Mohammad Amin Bhat & Ors. v/s State of J&K and others**".

Whereas, this office received a court order dated:- 12-06-2014 regarding above writ petition from Joint Registrar, High Court of J&K, Srinagar vide No. 24453, Dated:- 13-06-2014, received in this office on 14-06-2014. The operative part of which is as under:-

"Notice subject to objections and till next date before the Bench, it is provided that the tentative seniority list of Wildlife Guards issued vide order dated 5th May, 2014 shall not be acted upon for making any further promotions until objections of the petitioners in respect of the tentative seniority list are considered."

Whereas, in pursuance of Hon'ble Court order dated: 12-06-2014, all objections put forth by the petitioners were considered under rules and decided on the merits of each case.

Whereas, in the last meeting of Departmental Promotion Committee held on 28-07-2014, the Committee examined the procedure adopted for framing the final seniority and accordingly advised to issue the final Seniority List of Wildlife Guards in the larger interest of employees.

Whereas, a final seniority list of Wildlife Guards has been accordingly framed strictly in ascending order of date of appointment and inputs pertaining to category (reservation and qualification duly updated ending June, 2014 have been incorporated as per available records.

Now, therefore, the final seniority list of Guards formulated as above, is hereby notified for the information of all concerned officials for information.
