**Sub:** Final Seniority list of Foresters Category of the Wildlife Protection Department.

## NOTIFICATION

Whereas, the department had circulated tentative Seniority list of Foresters of the Wildlife Protection Department vide this office letter No: WLP/Estt/1542-53/09, dated: 27.8.2009.

Whereas, the aforesaid tentative seniority list was circulated again vide this office letter's No: WLP/Estt/1543-54/09, dated: 27.8.2010, No: WLP/Estt/403-5, dated: 14.6.2010, No: WLP/Estt/517-28, dated: 28.6.2010, and No: WLP/Estt/1269-72/10, dated; 4.12.2010 in order to obtain objections, if any from the concerned officials, with regard to their respective position shown against each as per tentative seniority list;

Whereas, the Hon'ble High Court in the writ petition No: SWP 615/95 titled Shri Gh.Mohd. Matta, passed the orders on 20.02.2006 as under:

"Under these circumstances, the petition is disposed of with a direction to the respondents to fix the same date of promotion for the petitioner on which date his Juniors were promoted to the higher posts as Dy.Foresters. While fixing the promotion due placement be made of the petitioner in the seniority list and the service benefits which accrue to him under rules by such placement shall be given to him.

Whereas, in pursuance of the Court directions, the Wildlife Protection Department vide its order No: 183 of 2006 dated: 12.10.2006 the petitioner was treated to have been promoted as Dy.Forester/Forester on notional basis with effect from the date his Juniors (following) had been promoted;

1. Shri Vijay Singh = Forester.
2. Shri Gh.Hassan Naikoo = Forester.
3. Shri Ali Mohd Malla = Forester.
4. Shri Khem Raj = Forester.

Whereas, the petitioner filed contempt petition No: 289/2006 in SWP No: 615/1995 on the ground that the action taken by the Hon'ble High Court has not been considered by the respondents.

Whereas, the Hon'ble High Court disposed off the contempt petition No: 289/2006 in SWP No: 615/1995 on 11.03.2008, the operative part of the directions are as under:-

"It appears that the respondents have promoted the petitioner from the date his Juniors came to be promoted. In the given circumstances, it cannot be said that the respondents have violated the court direction in any way. The contempt proceedings are accordingly dropped. It is, however, observed that the respondents shall pass order vis-a-vis placement of seniority and release of other service benefits in favour of the petitioner in terms of the judgment of this court dated 20.02.2006 read with order dated: 12.10.2006 contained in annexure-R/I to the statement of facts. The respondents shall complete this exercise within a period of three months. The period of three months shall commence from the date, copy of this order is served by the petitioner on the respondents."

Whereas, subsequently one Shri Khem Raj, Forester also filed writ petition

"This petition is disposed of with the directions to the respondents to convene the DPC a fresh and pass appropriate orders regarding confirmation of the petitioner as Range Officer Grade-II with effect from the date the petitioner is holding the aforesaid post in case he is found eligible. Let be this done with a period of three months from the date of receipt of copy of the order".

Whereas, in compliance to the Hon'ble High Court orders dated: 11.3.2008 in the case of Shri Matta, together with the earlier orders issued by the Hon'ble High Court dated: 20.2.2006 and in partial modification of office order No: 183 of 2006 dated: 12.10.2006, issued by the Wildlife Department , pending service benefits to Shri Gh.Mohd. Matta, Forester, were decided by the department vide order No: 346 of 2009 dated: 30.3.2009 whereby Shri Matta was treated to have been promoted as Dy.Forester w.e.f. 10.12.1985 and as Forester on notional basis w.e.f. 23.11.1992 (the date his Juniors have been promoted) and properly w.e.f 22.11.1996 as Forester subject to the final outcome of the SWP of Khem Raj V/s Gh. Mohd Matta and subsequent ratification by the Departmental Promotion Committee.

Whereas, Shri Ali Mohd. Malla and Gh. Hassan Naik, Guard were Graduate, therefore, taking cognizance of the subordinate recruitment rules of the Forest Department both the incumbents were promoted as Dy. Foresters w.e.f. 28.11.1992 and the under-graduates Forest Guards, (now Foresters) filed representations against these promotion orders. These representations have been examined and it has been found that at this point of juncture, the Department can not revoke the promotion orders after a decade as this will open flood gate of litigations and will jeopardize the promotion of pending seniority list again.

Whereas, in the above circumstances, Department vide its letter No: WLP/Estt/2012/5519-21, dated: 09.03.2012, enjoined upon all the Regional Wildlife Wardens to furnish the comments/observations on the tentative seniority list issued vide No: WLP/Estb/2021-23/10, dated: 03.02.2011 and also the representations if any be taken cognizance to enable this office to finalize the seniority list of Foresters category.

Whereas, the Regional Wildlife Warden, Jammu vide his letter No: CCF/WL/J/123, dated: 12.04.2012 expressed the views of all Wardens of the Region and treated the tentative seniority list of Foresters category as Final.

Whereas, the Chief Conservator of Forests (Wildlife)/Regional Wildlife Warden, Kashmir, vide his letter No: CCF (WL)/K/Estt/12-13/166, dated: 14.05.2012, endorsed the list after placing Shri Gh. Mohd. Matta at S.No: 2. This was in lieu of the revision of seniority of the incumbent issued vide Order No: CWLW: 346 of 2009 dated: 30.06.2009 in pursuance to Hon'ble Court direction.

Now therefore, in light of above, the notification for determining the Final seniority position of Foresters category (Appended to this notification) as it stood on 01.03.2013 in supersession of all previous seniority lists of Foresters is issued and circulated among all the concerned officials through the Conservator of Forests (Wildlife)/Regional Wildlife Wardens for their information.
