In the interest of administration, the following orders are hereby issued with immediate effect.

1. Shri Resh Paul, Range Officer Grade-II, Jammu Zoo, is hereby transferred and posted as Range Officer, Jammu in place of Shri Noor Mohd. Forester. He shall also look after the Wetland Range, Jammu by relieving Shri Vijay Singh, Forester (I/C Wetland Jammu).
2. Shri Noor Mohd, KFC Forester (I/C Range) Jammu is hereby transferred and posted as (I/C Range) Deer Park Jammu in place of Shri Raj Singh, Forester, who shall report to the Chief Conservator of Forests, Jammu. Shri Noor Mohd. will also look after the Jammu Zoo till further orders.
3. Shri Vijay Singh, KFC Forester, holding additional Charge as (I/C Range) Nandni will now continue as (I/C Range) Nandni.
4. Shri Sansar Chand, KFC Forester Mansar Range is hereby transferred and posted as (I/C Range) Sudhmahadev in place of Shri Kali Dass, Forester, who shall report to the Chief Conservator of Forests, Jammu.

It is further ordered that:-

- a. the transferees will move at once.
- b. the transfer order above is a stopgap arrangement and shall not confer any right on the transferees to stake claim for higher position except S.No: 1.
- c. the arrangement shall cease the moment when eligible candidates are posted against above I/C placements
