Terms & Conditions:

- 1. Bids uploaded must accompany scan copies of the following:
 - a. Govt. Treasury Receipt (cost of tender document) in shape of Treasury Challan for the amount shown against the work above to be deposited in Govt. Treasury under Account Head 0406- Forest.
 - b. Earnest money in shape of CDR pledged to Additional Wildlife Warden, Jambu Zoo, Jammu.
 - c. Latest Income Tax Return for the year 2022-23.
 - d. GSTIN for the latest quarter.
 - e. Registration Certificate (Nature of Business).
- 2. The price bids uploaded on the website in time will be opened after the evaluation of the Technical Bids by the Tender opening Committee of the Department. The dates of opening price bids as per NIT. The price bids will also be opened in the office of Regional Wildlife Warden, Manda Hills, Jammu.
- 3. The bids for the supply shall remain valid for a period of 90 days from the date of opening of bids, if any bidder/ tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the earnest money deposited shall be forfeited.
- 4. The Department shall not be held responsible for selection criteria/policy matter being adopted by the Directorate of Information regarding publishing the e-NIT, in any of the newspaper under circulation
- 5. The Department will not be responsible for any delay in online submission of the bid due to any reason (Technical or otherwise).
- 6. The accepting department however, reserves the right to reject any or all the tenders without assigning any reasons thereof.
- 7. The daily supply should reach to Jambu Zoo Jammu before 8.00 AM daily. In case of any deviation in timing, the contract / agreement shall be terminated.
- 8. The rates for the supply of required item be quoted per kg inclusive of all taxes, charges i.e transportation to Animal Kitchen Block at Jambu Zoo, Nagrota, Jammu.
- 9. The rates quoted should be inclusive of all the taxes, excise duty or any other levy etc.
- 10.The mixed feed and cereals to be supplied should be Clean, fresh, and good quality, odorless, high nutritious value etc.
- 11. The approximate supply for mixed feed and cereals is shown in BOQ which may change depending on the increase/ decrease in number of animals kept at the concerned Jambu Zoo without prior notice to the contractor.
- 12. No conditional tender will be entertained.
- 13. The rates offered by the successful tenderer/ lowest bidder shall be submitted to the competent authority for approval. The L1 bidder will have to execute an agreement with the Department/ office within a period of seven days from the date of issue of approval in his favour. In case of his failure, the sanction issued will be cancelled and earnest money deposited will be forfeited.
- 14. The Tender Opening Committee reserve the right to accept or reject any tender in whole or part without assigning any reason thereof.
- 15.In case of any dispute arising between the parties concerned the matter will be referred to the Chief Wildlife Warden, J&K for arbitration and his decision will be final and binding on both the parties.

- 16.After receipt of bill in duplicate for the month of supply duly authenticated by the Range Officer concerned, the due payment will be released in favour of the approved contractor subject to the availability of funds. The income tax/ other taxes, if payable under rules will be deducted at source as per the guidelines issued by the Income Tax Department/ Govt. from time to time.
- 17.In case of default in making daily supply of material/ quality by the approved contractor, the required material will be purchased from the open market at the cost, risk and responsibility of the concerned contractor. The difference, if any in rates approved and rates charged for arranging the supply from open market shall be debited from the pending payments/ security deposit to the contractor.
- 18. The E.M.D of the successful tender will remain as security deposit and will be released after the completion of work/allotted time period with the office.
- 19. Arbitration and Laws: In case of any dispute or difference arising out of or in connection with the conditions / order and Contract, the Department of Wildlife Protection and the bidder will address the dispute / difference for a mutual resolution and failing which, the matter shall be referred for arbitration to a sole Arbitrator to be appointed by Chief Wildlife Warden, J&K. The resolution of the Arbitrator shall be final and binding on both the parties.
- 20. The meat selected for shall be of good quality, obtained from the carcasses of only healthy animals, slaughtered in licensed premises & subject to proper ante-mortem & post-mortem inspection by a representative of competent authorities.
- 21. The objections regarding NIT term & conditions can be raised/ communicated in writing to this office within 10 days of the floating of NIT.
- 22. The material shall be free from artificial coloring matter & other preservatives.
- 23. The material shall have the characteristics taste & smell, typical of good meat. It shall be free from any objectionable odour or colour, pest/ worms etc.
- 24. The period of contract will be of one-year i.e from the date of issuance of work order to the lowest bidder.
- 25. The bidder shall submit quality assurance certificate issued by the competent authority at least on quarterly basis.
- 26. The item should be of good quality, to be fit for human consumption. Free from dampness, mould, fungus or any other contaminants.
- 27. The quantity of each item is tentative and is liable to be increased or decreased by the zoo authority according to the requirement, circumstances or health conditions of the animals. The contractor will not claim any compensation for any loss due to change in the quantity of any item.
- 28.On receipt, the supplies will be weighed at the feed store or any other place and any shortage will be treated as non-supply and will be dealt as per the terms & conditions of tender.
 - 29. The contractor will be responsible to obtain a receipt after weighing of supplies from the official deputed to receive the supplies which will be attached with the bills to be submitted by the contractor.
 - 30. The supplies/items/articles at any point of time may be inspected by the Additional Wildlife Warden Jambu Zoo or his authorized representative or any other zoo official not below the rank of a Range Officer in presence of concerned feed store incharge and they will have the right to reject the supply in case of short supply or if the standard does not meet the specifications.

In case of defective/substandard supplies or in case of non supply/ short supply/delayed supply, the purchase shall be effected by

Additional Wildlife Warden Jambu Zoo or his authorized representative from the open market. Any amount so incurred for the said purchase including carriage, transportation etc. will be recovered from contractor or his security deposit or as arrear of land revenue till the new contract is finalized.

- 31. Due to Administrative reasons/public interest/any emergency reasons, the supply of any of the item/article may be stopped or quantity may be reduced/increased, at any point of time during the tender period. The source of the supply of any item can be changed at any time without any prior notice. The tenderer will not claim any compensation for any loss due to change in quantity/source of any of the item.
- 32. Due to administrative/Public interest/any emergency reasons, the zoo administration may impose any restrictions/changes in the process of supply and delivery of any items in the zoo.
- 33. TDS as applicable will be deducted from the payments of tenderer.
- 34. In the event of supplies not conforming to specified quality Additional Wildlife Warden Jambu Zoo may at his sole discretion reject or accept the supplies subject to such reduction in the price as the supplies or the quality of the supplies accepted.
- 35. The quotations may be accepted in whole.
- 36. The items supplied or to be supplied may be tested for quality in feed store or through any private lab or through any institute by the Range Officer of Jambu Zoo, the expenditure, if any, will beborne by the contractor.
- 37. In case of any Epidemic/Pandemic/Disaster/ any other difficult situation, due to which the cost of item/supply/delivery is escalated in the market or any other source, it shall be borne by the tenderer. The contractor will ensure the supply of the item as per the terms and conditions of the tender. The contractor will not claim any compensation for any loss due to any disaster or inflation or cost escalation during the contract period.
