Fresh Tender Notice No:- 19 Dated:-. 21-09-2016

For and on behalf of the Governor, J&K state, sealed tenders affixed with Rs. 5/- (Rupees five) Revenue Stamps are invited from the registered / licence holder pharmaceutical dealers for supply of drugs/ medicines to the wildlife Protection Department for tranquilization of Wild Animals during the financial year 2016-17, as per the following details.

(Note: - The drugs are used for wild animals like Leopard, bear, deer etc.)

- The tender documents can be had from the office of Regional Wildlife Warden Kashmir, Srinagar against cash payment of Rs.500/=.
- The tender shall be accompanied by a CDR of an amount of Rs.20000/=of any nationalized Bank pledged to the undersigned as the earnest money deposit. The EMD of the successful tenders shall be accounted towards part of the contract.
- The earnest money deposit of second lowest tenderer will be retained till the sanction is issued in favour of the successful tenderer. The CDR for other unsuccessful tenderers shall be released immediately after the opening of the tenders, and that of the successful tenderer on the satisfactory completion of contract or the end of financial year, whichever is earlier.
- The tender shall be addressed to the Regional Wildlife Warden, Kashmir Region, Near Police Golf course, Boulevard Road, Srinagar and should be sent either under registered cover or deposited in the tender box kept in the above said office up to-19.10.2016(Wednesday) 12.00 Noon. No late tender than the specified date and time will be entertained.
- The tender shall be opened on 20.10.2016 at 02.00 PM or any other subsequent day in presence of the tenderers or their authorized representatives, who may wish to remain present on the occasion.
- . The tender shall be clearly written in ink legibly. Cuttings, errors and interpolations if any shall make the tender invalid.
- The rate quoted shall be for complete unit inclusive of all taxes, duties and F. O. R. destination Site.

 The VAT and Income Tax clearance certificates ending latest quarter should be attached with the tender documents.

General terms and conditions:

- 1. The dealer should be registered with the Drug Controller Jammu and Kashmir/India
- 2. The supplier shall submit the test Analysis Report for every batch of drug along with the invoice.
- 3. The items supplied should meet the standard safety, efficacy and quality.
- The item should possess minimum life of 24 months at the time of receipt by the department.
- The successful tenderer shall have to make the supplies within one month from the date of issue of supply order to be made to all the wildlife wardens of the Kashmir Province. The location wise list of offices shall be supplied along with Tender Documents.
- 6. The successful tenderer shall have to execute an agreement with the department within a period of 7 days from the date of issue of approval in his favour. In case of his failure the sanction issued will be cancelled and earnest money deposit forfeited.
- 7. No conditional tender shall be entertained.
- The payment shall be released after the verification of the supply by the concerned Wildlife Warden and Veterinary Surgeon of the Wildlife department and fulfilment of all the terms and conditions guided by the agreement.
- The undersigned reserves the right to accept or reject any tender or part of it without assigning reasons thereof.
- 10. In case of default in supplies the department shall make the purchases from the open market recovering the extra charges if any from the tenderer.
- 11. In case of any dispute arising between the parties concerned the matter will be referred to the Chief wildlife Warden, J&K for arbitration and his decision shall be final and binding on both the parties.
