For and on behalf of the Governor Jammu and Kashmir State, sealed tenders affixed with Rs, 5/ Revenue stamp are invited from registered PWD contractors for execution of the following works, which should reach the office of the Wildlife Warden, Central Division Srinagar on or up to 7th Day of December 2016 2:00 PM. The earnest money @ 2% of the total cost pledged to the Wildlife Warden Central Division Srinagar shall be enclosed with the tenders. The tender documents, along with BOQ and other details of works can be seen/purchased from the office of the Wildlife Warden Central Division Srinagar from 19th of November 2016 up to 6th day of December 2016, 4:00 PM against a cash payment shown as against each work. The tenders shall be opened by the tender opening committee soon after receipt of tenders, or any other subsequent day in presence of the tenderers for their authorized representatives, who so ever may like to be present

Terms and Conditions

- 1. The tenders shall be free from cuttings, correction/insertions. Tenders having corrections/cuttings/insertions shall be out rightly rejected.
- 2. The conditional tenders shall be rejected.
- 3. The contractor shall quote the rates inclusive of all the incidental charges, VAT, Octroi and other levies etc, and no extra payment on this account shall be made.
- 4. No storage for material shall be provided by the Department for which the contractor shall have to make the arrangement of his own.
- 5. The contractor shall attach the tax clearance certificates with respect to sales tax and income tax for the assessment year 2015-16 with the tenders, falling which the tenders shall be rejected.
- 6. No payment on a/c of diversion and dewatering shall be made to the contractor.
- 7. The details, drawings, design, specification can be seen in the office of the undersigned during working hours.
- 8. No compensation to the damages occurred during execution due to natural calamities, shall be made and the damages if any caused during the currency of the work shall have to be rectified but the contractor on his own.
- 9. The key construction material i.e cement, steel, crates shall be arranged by the contractor on his own confirming to the specifications and standards of BIS.
- 10. The taxes, levies as admissible under rules from time to time shall be deducted at source from the bills of the
- 11. A deposit of 10% shall be retained on all running account bills of the contractor.
- 12. The tenderers shall quote their rates on the BOQ.

- 13. The work shall be completed strictly as per the specification drawings (as per annexure to NIT). The contractor shall be personally responsible for maintaining the specifications of the work and substandard work shall not be extentioned.
- 14. The quantities mentioned in the NIT are subject to increase or decrease during execution as per site condition.
- 15. Any item/items of work not mentioned in this NIT and found necessary at site during execution as per site condition, shall have to be executed by the contractor on the same allotted rates/SSR appreciation/depreciation as the case may be.
- 16. No activity shall be undertaken by the contractor against the provision of J&K Wildlife Protection Act amended 2002, and in case of any violation action under the provisions of the Act shall be initiatedagainst the contractor, his representative or worker if any.
- 17. In case of any dispute arising between the contractor and the department, the case shall be referred to the PCCF Wildlife/Chief Wildlife Warden J&KGovernment, whose decision shall be final, binding and operative upon the parties.
- 18. Other terms and condition not covered under this NIT shall be same as are in vogue in the PWD and prescribed in PWD form (25) double.
- 19. The department reserves the right to reject or accept any or all the tenders without assigning any reason thereof.
